“ Agenda:-

(1) To peruse the judgment of the Hon’ble High Court in W.P. (C) No.33980 of 2015 (V) dated 15/12/2016.

(2) To consider the representation filed by the All Kerala Bus Operators Organization, Palakkad and Kerala State Private Bus Operators Federation, Ananda valleswaram, Kollam in fixing the age limit for the stage carriages in applying and granting fresh regular stage carriage permits.

Decision: -

Perused the judgment in W.P. (C) No.33980 of 2015 (V) dated 15/12/2016, heard the counsel for the applicants and objectors and decided to fix the age limit for the stage carriages in applying and granting fresh regular stage carriage permits as follows.

- a) 8 years for ordinary stage carriages***
- b) 7 years for city/town stage carriages and***
- c) 5 years for LSOS.***

However, the life span of the stage carriages will be the same as per the earlier decision of the STA i.e., 15 years for ordinary city services and 10 years for LSOS.”
